On May 28 and 29, 2003, the NRC staff (the staff) and representatives from OPPD (the applicant) held meetings to discuss draft responses to open items resulting from the staff's review of the applicant's license renewal application (LRA). Meeting participants are provided in Enclosure 1.

Open Item 3.0-1

In its letter dated March 14, 2003, the applicant provided revisions to many tables in LRA Sections 2 and 3. The staff will review the revised information to determine whether the revisions change the staff's conclusions as documented in the SER.

Meeting Discussion

The staff prepared a summary table of the LRA table changes (see meeting handout in Enclosure 2). The LRA table changes and bases for the changes were discussed with the applicable NRC reviewers.

During the meeting, the applicant and staff agreed to several additional revisions, including changes to the format of the summary table, that should be made and included as part of the official open item response. The table that will be included with the open item response will include columns containing the line item number, the LRA table in which the change is made, a description of the change, the reason for the change, and clarification about the change were requested by the NRC reviewers.

Of the 212 line items, 9 (item numbers 10, 31, 43,44, 79, 123, 135, 145, and 154) required further clarification.

Line items 5, 22, 41, 103, 140, and 197 were clarified during the meeting discussions of those items. The additional information provided at the meeting will be included in the "Clarification" column.

During the meeting discussions, the participants determined that 9 of the line items 61, 93, 97, 124, 138, 142, 149,186, and 203 included changes that were inappropriate and should be retracted. The line items will remain in the table with a note that the information was retracted.

The rest of the matrix line items remained unchanged as a result of the meeting discussions.
