On September 28th, 2006, the U.S. Nuclear Regulatory Commission staff held a meeting, via teleconferencing, with stakeholders and the public to discuss Frequently Asked Questions (FAQs) at plants that are adopting National Fire Protection Association Standard 805. Preliminary positions with respect to several questions were discussed, tentative approval was reached on one question, and draft consensus positions were achieved on two others. Two new questions were also introduced and five future questions were briefly discussed. The participants determined that tentatively approved FAQs should be rewritten to reflect the final language, additional discussions should occur concerning the remaining preliminary positions, and that draft positions should be developed for the newly introduced questions.

All participants agreed that the next monthly meeting should occur on October 26th and preferably be a conference call.
