PURPOSE

This purpose of the in-office review was to evaluate, in detail, the staff's preliminary review of Sections 3 and 4 of the Fundamental Nuclear Material Control (FNMC) Plan for material control and accounting (MC&A) for the Mixed Oxide Fuel Fabrication Facility (MFFF).

DISCUSSION

The following is a summary of the topics that were evaluated during the review:

The applicant provided an overview of the MFFF FNMC plan, Section 3, "Alarm Resolution." This included alarm resolution, abrupt loss detection, trend analysis and item alarms, response time, item discrepancies, alarm reporting, alleged theft and item control system.

MOX Services also provided an overview of MFFF FNMC plan, Section 4, "Quality Assurance." This included management structure, personnel qualification and training, measurements and measurement control, physical inventory, accounting, shipments and receipts, scrap control, human errors, independent assessment, and special strategic nuclear material custodianship.

The next in-office review on MC&A will be held in June 2008 to discuss the staff's detailed comments on the FNMC.

No regulatory decisions were made at this meeting.

The review was then adjourned.
