PURPOSE

The purpose of the closed meeting was for Shaw AREVA MOX Services (the applicant) personnel to present and discuss with the U.S. Nuclear Regulatory Commission staff their draft responses to the staff's requests for additional information (RAI) pertaining to the criticality safety review of the license application (LA) and integrated safety analysis summary for the Mixed Oxide Fuel Fabrication Facility.

DISCUSSION

In order to facilitate communication between the applicant and the staff and to assure an understanding of the applicant's responses to the staff's RAIs, a meeting was held to discuss the applicant's draft responses to the staff's questions regarding the criticality safety review. The RAIs relate to: (a) the commitments in the LA regarding the criticality safety organization and reporting requirements; (b) the definitions of various safety margin terminology; (c) the methods used to assure sub-criticality and the assumptions in the analyses; (d) application of a sampling plan for criticality prevention items relied on for safety; and (e) common mode failure and independence of administrative controls.

The staff and the applicant will meet again prior to the formal submittal of the criticality safety RAI responses by the applicant.

No regulatory decisions were made at the meeting.

The meeting was then adjourned.
