SUBJECT: SUMMARY OF AUGUST 27, 2009, CATEGORY 2 MEETING
REGARDING THE NATIONAL FIRE PROTECTION ASSOCIATION
STANDARD 805 FREQUENTLY ASKED QUESTION PROCESS

On August 27, 2009, the U.S. Nuclear Regulatory Commission (NRC) staff held a meeting with stakeholders and the public to discuss Frequently Asked Questions (FAQs) at plants that are adopting National Fire Protection Association (NFPA) Standard 805. Licensees and the NRC staff discussed the currently open FAQs. Licensees made a presentation regarding FAQ 09-0057, and the NRC staff asked clarifying questions. The participants determined that both industry stakeholders and the NRC staff needed to continue to work on the remaining open FAQs.

Participants discussed publicly available NRC draft interim positions on two FAQs (08-0048 and 08-0050) related to NUREG/CR-6850, and licensees were given the opportunity to ask clarifying questions. Licensees stated that they expected to have comments on the draft interim positions.

NRC staff presented updated schedules for the review of the pilot plants' license amendment requests and development of NFPA 805 infrastructure.

Participants agreed that the next FAQ meeting would take place on September 30, 2009. Future meetings were also scheduled for October 22, November 19, and December 17, 2009.
