SUBJECT: SUMMARY OF DECEMBER 17, 2009, CATEGORY 2 MEETING
REGARDING THE NATIONAL FIRE PROTECTION ASSOCIATION
STANDARD 805 FREQUENTLY ASKED QUESTION PROCESS

On December 17, 2009, the U.S. Nuclear Regulatory Commission (NRC) staff held a meeting with stakeholders and the public to discuss Frequently Asked Questions (FAQs) at plants that are adopting National Fire Protection Association (NFPA) Standard 805. Licensees presented comments related to FAQ 09-0056. NRC staff presented comments on FAQ 09-0057 and technical agreement was reached pending an additional editorial change that would be reflected in a new revision that licensees would submit. Licensees and the NRC staff discussed the remaining currently open FAQs. The participants determined that both industry stakeholders and the NRC staff needed to continue to work on the remaining open FAQs.

Licensees were given the opportunity to ask clarifying questions regarding the NRC draft interim position on a FAQ (08-0051) related to NUREG/CR-6850. Licensees indicated that they had no questions or comments regarding the draft interim position.

NRC staff presented updated schedules for the review of the pilot plants' license amendment requests and development of NFPA 805 infrastructure.

Participants agreed that the next FAQ meeting would take place on January 28, 2010, via teleconferencing. Future meeting dates were tentatively set for February 25, 2010, and March 18, 2010.
