SUBJECT: SUMMARY OF THE JUNE 23, 2010, CATEGORY 2 MEETING  
REGARDING THE NATIONAL FIRE PROTECTION ASSOCIATION  
STANDARD 805 FREQUENTLY ASKED QUESTION PROCESS

On June 23, 2010, the U.S. Nuclear Regulatory Commission (NRC) staff held a meeting with stakeholders and the public to discuss Frequently Asked Questions (FAQs) at plants that are adopting National Fire Protection Association (NFPA) Standard 805. Licensees and the NRC staff discussed the list of currently open FAQs. The participants determined that both industry stakeholders and the NRC staff needed to continue to work on the remaining open FAQs.

Licensees presented and discussed a revision of FAQ 07-0030, which has to do with recovery actions, as well as a related flowchart. The licensees stated that the new revision closely follows the process used by both pilots and many non-pilots, but with refinements and clarifications. The participants also concluded that while resolution of this FAQ is a high priority, unless there are substantial changes made to the process, the immediate resolution of this FAQ is not required for the completion of the analyses at the non-pilots or the remaining pilot.

The NRC staff discussed the status of FAQ 08-0053 which deals with the categorization of Kerite cables. The staff noted that their response is on hold pending receipt of the test report from last summer's cable testing, and that additional test information would be available by the end of 2010. Licensees expressed concern regarding the length of time involved in resolving this FAQ and timeliness of the test results. Licensees and the NRC staff determined that licensees could perform their analyses using current guidance.

The NRC staff discussed forthcoming changes proposed to be made to FAQ 09-0056, which concerns radioactive release transition. To summarize the proposal:

- Where containment of gas and liquid effluents can be demonstrated, most likely no further analysis is needed.
- Where such containment cannot be demonstrated, further evaluation is required, possibly including quantitative analysis.
