SUBJECT: SUMMARY OF THE OCTOBER 7, 2010, CATEGORY 2 MEETING
REGARDING THE NATIONAL FIRE PROTECTION ASSOCIATION
STANDARD 805 FREQUENTLY ASKED QUESTION PROCESS

On October 7, 2010, the U.S. Nuclear Regulatory Commission (NRC) staff held a meeting with stakeholders and the public to discuss Frequently Asked Questions (FAQs) at plants that are adopting National Fire Protection Association (NFPA) Standard 805. This meeting was focused on FAQ 10-0058, which deals with the generic License Amendment Request (LAR) template.

The NRC staff presented comments on the following sections of the template:

- 4.1 Fundamental Fire Protection
- 4.4 Radiological Release
- Attachment A B-1 Table
- Attachment E G-1 Table Radiological Release
- Attachment H FAQ Summary Table
- Attachment I Power Block
- Attachment L Chapter 3 Requirements for Approval Under (c)(2)(vii)

The NRC staff comments on these sections are included in the meeting handout identified below. The handout also includes a number of comments on additional sections that were not discussed. Licensees agreed to incorporate the discussed comments into the appropriate template sections.

Licensees and the NRC staff discussed the path forward on the LAR template. The participants agreed that FAQ 10-0058 should be withdrawn from the FAQ process, and that comments on the LAR template would be discussed in a separate series of public meetings. The NRC staff stated that a publically available memo would be issued to close the FAQ.
