SUBJECT: SUMMARY OF THE OCTOBER 21, 2010, CATEGORY 2 MEETING  
REGARDING THE NATIONAL FIRE PROTECTION ASSOCIATION  
STANDARD 805 FREQUENTLY ASKED QUESTION PROCESS

On October 21, 2010, the U.S. Nuclear Regulatory Commission (NRC) staff held a meeting with stakeholders and the public to discuss Frequently Asked Questions (FAQs) at plants that are adopting National Fire Protection Association (NFPA) Standard 805. Licensees and the NRC staff discussed the list of currently open FAQs. The participants determined that both industry stakeholders and the NRC staff needed to continue to work on the remaining open FAQs.

The NRC staff stated that they expected to submit comments on FAQs 07-0030 (recovery actions) and 07-0038 (multiple spurious operations) by the November monthly public FAQ meeting and on FAQ 08-0054 (Chapter 4 compliance) by the December monthly meeting.

NRC staff presented an updated schedule for the review of the Oconee pilot plant's license amendment request.

Participants agreed that the next monthly FAQ meeting would take place on November 18, 2010, via teleconferencing. The industry stakeholders requested that additional FAQ public teleconferences take place on November 4, 2010, and December 2, 2010. The NRC staff stated that they would consider the proposal, and later agreed to hold these additional meetings.
