SUBJECT: SUMMARY OF THE NOVEMBER 18, 2010, CATEGORY 2 MEETING
REGARDING THE NATIONAL FIRE PROTECTION ASSOCIATION
STANDARD 805 FREQUENTLY ASKED QUESTION PROCESS

On November 18, 2010, the U.S. Nuclear Regulatory Commission (NRC) staff held a meeting with stakeholders and the public to discuss Frequently Asked Questions (FAQs) at plants that are adopting National Fire Protection Association (NFPA) Standard 805. Licensees and the NRC staff discussed the list of currently open FAQs. The participants determined that both industry stakeholders and the NRC staff needed to continue to work on the remaining open FAQs.

Licensees presented new revisions of FAQs 07-0030, which deals with recovery actions, and 07-0038, which deals with multiple spurious operations, that incorporated NRC comments. The NRC staff confirmed that technical agreement had been achieved on these two FAQs, with the incorporation of previous NRC comments.

Licensees inquired about the NRC schedule for presenting comments on FAQ 08-0054, which deals with compliance with NFPA 805 Chapter 4. The NRC staff stated that their goal was to provide the comments by the mid-December public meeting, but that they would attempt to have the comments ready for the early December meeting.

NRC staff presented an updated schedule for the review of the Oconee pilot plant's license amendment requests.

Participants agreed that the next FAQ meeting would take place on December 2, 2010, via teleconferencing. A future meeting was tentatively scheduled, as a teleconference, for December 15, 2010.
