Enclosed is the NRC staff's safety and environmental review schedule for the Davis-Besse Nuclear Power Station, Unit 1 (DBNPS), license renewal application (LRA). This customized schedule has been established to accommodate a timely review of your application along with all other concurrent reviews of applications for license renewal. Due consideration was also given to your staff's input regarding the plant's outage schedule and their ability to support the safety and environmental on-site audits. The NRC staff will follow established review procedures and the enclosed schedule to complete the reviews required by Parts 54 and 51 of Title 10 of the *Code of Federal Regulations*.


We would like to emphasize that the staff will perform a very detailed and thorough review of your LRA. The NRC staff will make every effort to meet the scheduled milestones. To support this effort, your responses to the staff's requests for additional information (RAIs) must be complete and provided in a timely manner. The enclosed issue and response dates for RAIs reflect end dates; RAIs will be issued in several groups during the environmental and safety reviews up until these established end dates. You will be afforded an adequate timeframe to respond to each group of RAIs (typically 30 days). The timeliness of your responses is necessary to maintain the schedule, and delays could result in revisions to the enclosed established schedule. We request that you inform the NRC staff as early as possible should potential delays arise in your support of this schedule.
