SUBJECT: SUMMARY OF THE DECEMBER 16, 2010, CATEGORY 2 MEETING  
REGARDING THE NATIONAL FIRE PROTECTION ASSOCIATION  
STANDARD 805 FREQUENTLY ASKED QUESTION PROCESS

On December 16, 2010, the U.S. Nuclear Regulatory Commission (NRC) staff held a meeting with stakeholders and the public to discuss Frequently Asked Questions (FAQs) at plants that are adopting National Fire Protection Association (NFPA) Standard 805. Licensees and the NRC staff discussed the list of currently open FAQs. The participants determined that both industry stakeholders and the NRC staff needed to continue to work on the remaining open FAQs.

The NRC staff discussed the status of FAQ 09-0053, which deals with Kerite cable categorization. The staff stated that they expected the final test report to be submitted to the NRC in early January, and that they planned to issue it to the public by the end of February.

The NRC staff presented and discussed revised comments on FAQ 08-0054, which deals with compliance with NFPA 805 Chapter 4. Licensees and the NRC staff discussed the comments, and the licensees stated that they would incorporate the comments in a new revision of this FAQ and submit it to the NRC on December 17.

NRC staff did not present an updated schedule for the review of the Oconee pilot plant's license amendment request, but noted that the previous schedule update was a handout for this meeting.

Participants agreed that the next FAQ meeting would take place on January 20, 2011 via teleconferencing. A future meeting was scheduled, as a teleconference, for February 17, 2011.
