


Figure 1. Location of Proposed Site for the AREVA Enrichment Plant.

AREVA is preparing an application to the U. S. Nuclear Regulatory Commission (NRC) to construct, operate, and decommission a gas centrifuge uranium enrichment facility in Bonneville County, Idaho. The proposed plant would be located on 4000 acres of private land about 20 miles west of Idaho Falls on the north side of U.S. Highway 20. The proposed site would include Sections 13-15, and portions of Sections 21-26, all in Township 3N and Range 34E (see Figure 1). Only about 800 acres would be directly impacted by construction of the facilities and access roads.

The NRC requires a license applicant to assess the impacts of its proposed action on the environment. AREVA will document this assessment in an Environmental Report (ER) that will be submitted to the NRC as part of the formal license application. The NRC will then prepare an environmental impact statement (EIS) in compliance with the *National Environmental Policy Act* (NEPA) as part of the licensing process. In addition, the NRC will contact you and, if needed, initiate consultations.

We are contacting you early in the application process to inform you of this project and to ask for information and comments related to archeological, cultural, and historical sites that would be relevant to our analysis of this project. To facilitate your review, a short description of the project and a site map of the project area are enclosed with this correspondence.

Description of the Proposed AREVA Uranium Enrichment Facility

AREVA proposes to construct, operate, and decommission a gas centrifuge uranium enrichment plant in Bonneville County, Idaho. It is planned that the low enriched uranium produced at the proposed facility would be shipped to fuel fabrication facilities located in other states and used to manufacture nuclear fuel for commercial nuclear power reactors in the United States. Uranium enrichment is one step in the nuclear fuel cycle shown on the next sheet. The process at this proposed facility will enrich the U235 component of natural uranium to three to five percent U235.

Schedule

There are four main stages of this project:

- Submit license application to U.S. Nuclear Regulatory Commission (NRC) (Late 2008-early 2009)
- NRC review and approval (expected in 2011)
- Site preparation and construction (2011 to 2018)
- Facility Operation (2014 to 2038)

Site Location


The proposed facility would be located approximately 18 miles west of Idaho Falls immediately north of U.S. Highway 20 (Figure 1). The proposed site encompasses approximately 4000 acres, with about 800 acres to be developed for the plant (buildings, storage pads, etc.), access roads, and utilities.

Site Description

The proposed site is in a rural area of Bonneville County with limited development within **10 miles** of the site. The property is privately owned and AREVA would purchase the property prior to development. The land is undeveloped and is a mixture of rangeland and farmland.

Various buildings and structures would be needed for the proposed enrichment facility. These include main plant process buildings housing the enrichment process, technical support buildings, outdoor and indoor storage areas, shipping and receiving areas, an administration building, and a visitor center.

Two access roads to U.S. Highway 20 would be constructed on the site. In addition, power lines would be constructed to the site from existing transmission lines in the area. An onsite well would be used to provide water.



Simplified Depiction of the Uranium Fuel Cycle and Electrical Power Uses.

Thank you for notifying us of AREVA's application to the Nuclear Regulatory Commission (NRC) to construct a uranium enrichment facility on 4000 acres of private land located 20 miles west of Idaho Falls. Actual construction will take place on 800 acres in parts of sections 13, 14, and 23, T3N, R34E.

We understand that AREVA plans to conduct an archaeological survey of the project area. We anticipate that archaeological properties will be identified within the project area, and archaeological testing and data recovery may be required. These investigations, review of the reports, and consultation with our office and the Shoshone-Bannock Tribes will take time, so please schedule the project accordingly.

You should also be aware that we are concerned about potential visual effects on archaeological site 10BV47, located less than two miles to the northeast of the construction footprint. 10BV47 (the Wasden site, also known as Owl Cave) is a nationally significant site that contained Pleistocene faunal remains and associated cultural materials over 12,000 years old. The setting and landscape of this Paleoindian site contribute to its significance.

Finally, you note in your letter that you are contacting us as part of NEPA compliance. Federal agencies, like the NRC, are also required to comply with Section 106 of the National Historic Preservation Act. Our office advises and provides professional opinions to the Federal agency throughout the Section 106 Review process (36CFR800). It is in this capacity that we will be reviewing this project.



I am writing to let you know that AREVA Enrichment Services LLC is preparing an application to the U. S. Nuclear Regulatory Commission (NRC) to construct, operate, and decommission a gas centrifuge uranium enrichment facility in Bonneville County, Idaho. The proposed plant would be located on private land, approximately 18 miles west of Idaho Falls and just north of Highway 20.

As your may know, last Thursday AREVA met with several members of your staff including Willie Preacher and Carolyn Boyer-Smith to discuss the planned project. We very much appreciate the time they spent with us. The meeting was helpful and informative to us and we hope to continue this dialogue with you and the Council Members during our scheduled meeting on September 11. In the meantime, we would appreciate your assistance to address several environmental questions.

- 1. Are there areas where tribal trust lands or traditional use areas exist within Bonneville, Jefferson and Bingham counties and where are these lands located?
- 2. Are there places within these three counties where concentrations of tribal members reside?

- 3. We would appreciate you or your staff providing a list of (a) key terrestrial plants, wildlife species, fish and aquatic plants that are typically collected or harvested for ceremonial or medicinal purposes or as a source of food and, (b) the areas where these species are typically harvested or collected by Tribal members.
- 4. AREVA would be interested in your views on the potential effects of our proposed project on Tribal trust lands, traditional use areas, Tribal ceremonial activities (such as the Shoshone-Bannock Festival and Indian Day), and on Tribal plant and animal collecting or harvesting that may occur in the future recognizing the project will be located on private land. Would you please share your thoughts with us?

We look forward to meeting you and the Council members in September so we can introduce you to AREVA and its project. In the meantime, if you should have any questions regarding this letter or would like to discuss any matters with me, please feel free to contact me directly at the below listed phone number. Your responses to this request for information would be most helpful if received by September 15, 2008.



Simplified Depiction of the Uranium Fuel Cycle and Electrical Power Uses.




Figure 1. Location of Proposed Site for the AREVA Enrichment Plant.
