SUBJECT: SUMMARY OF THE OCTOBER 20, 2011, CATEGORY 2 MEETING
REGARDING THE NATIONAL FIRE PROTECTION ASSOCIATION
STANDARD 805 FREQUENTLY ASKED QUESTION PROCESS

On October 20, 2011, the U.S. Nuclear Regulatory Commission (NRC) staff held a meeting with stakeholders and the public to discuss Frequently Asked Questions (FAQs) at plants that are adopting National Fire Protection Association (NFPA) Standard 805. Licensees and the NRC staff discussed the list of currently open FAQs. The participants determined that both industry stakeholders and the NRC staff needed to continue to work on the remaining open FAQs.

The NRC staff discussed the status of FAQ 08-0053, which deals with Kerite cable categorization. The staff stated that final approval had been received from Sandia National Laboratory to publish the final report. The staff will announce the public availability of the report at the next FAQ meeting following its issuance.

The staff presented and discussed their comments on Revision 2 of FAQ 10-0059, which deals with the NFPA 805 Monitoring Program. The licensees stated that they would be incorporating the comments into a new revision of the FAQ.

Both the licensees and the staff agreed that further discussion of the requirements for focused scope peer-reviews and the licensees' proposal to expand the scope of the monthly FAQ public meetings should be deferred to future meetings.

Participants agreed that the next FAQ meeting would take place on November 17, 2011, via teleconferencing.
