Supplemental Information in Support of Request for Consent to Indirect Transfer of Control of Construction Authorization No. CAMOX-001

By the Reference letter dated August 30, 2012 (August 30 Letter), Shaw AREVA MOX Services, LLC (MOX Services) requested that the U.S. Nuclear Regulatory Commission (the NRC) consent to the indirect transfer of control of Construction Authorization No. CAMOX-001 (the CA) for the Mixed Oxide Fuel Fabrication Facility (MOX Facility) now being constructed at the U.S. Department of Energy Savannah River Site in Aiken, South Carolina. The indirect transfer would result from a proposed transaction whereby The Shaw Group Inc. (Shaw) would be acquired by and become a wholly owned subsidiary of Chicago Bridge & Iron Company N.V. (CB&I).

In describing the proposed transaction, the August 30 Letter and its enclosed Figure 2 indicated the new name "CB&I Shaw Inc." for Shaw following the proposed transaction. The purpose of this letter is to clarify that Shaw will retain its existing registered name (The Shaw Group Inc.), but CB&I plans to operate Shaw as a separate business sector under the brand name CB&I Shaw. This clarification is administrative in nature, and it does not impact any of the material information provided in support of the request for indirect license transfer approval. This additional information does not impact the structure of the proposed transaction or the ownership of MOX Services as described in the August 30 letter. Nor does it impact the name of MOX Services, the entity to which the Construction Authorization is issued. A revised version of Figure 2 is attached.
