Dear Mr. Lieb:

By letter dated August 27, 2010, FirstEnergy Nuclear Operating Company (FENOC) submitted an application pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR) Part 51 and 10 CFR Part 54, to renew Operating License NPF-003 for the Davis-Besse Nuclear Power Station, Unit 1 (Davis-Besse), for review by the U.S. Nuclear Regulatory Commission (NRC or the staff).

Enclosed is the NRC staff's revised safety review schedule for the Davis-Besse license renewal application (LRA). The staff has revised the license renewal review schedule to delay the final safety evaluation report (SER) issuance and the Advisory Committee on Reactor Safeguards full committee meeting by three months each because the staff requires additional time to resolve open items and complete a thorough review of additional information regarding the aging management program for the shield building cracks.

To support the revised schedule milestones, your responses to the staff's request for additional information (RAI) must be complete and provided in a timely manner. After receiving the RAI responses, the staff will review and incorporate the responses into its safety review. Any delay in your responses could result in additional revisions to the enclosed schedule with the potential of leaving milestone schedule dates to be determined until responses are received and appropriately factored into a new schedule. We request that you inform the NRC as soon as possible regarding any potential delays.


