SUBJECT: SUMMARY OF JUNE 2014 QUARTERLY MEETING WITH THE
NUCLEAR ENERGY INSTITUTE AND INDUSTRY TO DISCUSS
REGULATORY ISSUES REGARDING THE CUMULATIVE EFFECTS
OF REGULATION FOR FUEL CYCLE FACILITIES

The staff of the U.S. Nuclear Regulatory Commission (NRC) met with the fuel cycle industry and the Nuclear Energy Institute (NEI) representatives on June 9, 2014, in Rockville, Maryland. The purpose of the Category 2 public meeting was to discuss the cumulative effects of regulation as described in the meeting announcement (Agencywide Documents Access and Management System (ADAMS) No. ML14142A308). The NRC staff presented updates to the regulatory items listed on the fuel cycle Integrated Schedule and Supplement (<http://www.nrc.gov/materials/fuel-cycle-fac/regs-guides-comm.html#cumeffects>). NEI presented a draft Regulatory Issue Resolution Protocol (ADAMS No. ML14149A423) for NRC's comment and consideration of endorsement. The process provides a step-by-step procedure to identify, track, and bring to closure generic regulatory initiatives.
