On March 12, 2012, the Nuclear Regulatory Commission (NRC) issued Order EA-12-051, "Order Modifying Licenses with Regard to Reliable Spent Fuel Pool Instrumentation," to PPL Susquehanna, LLC (now known as Susquehanna Nuclear, LLC). This Order was effective immediately and directed Susquehanna Units 1 and 2 to install reliable spent fuel pool instrumentation as outlined in Attachment 2 of the Order. This letter, along with its
