SUBJECT: SUMMARY OF SEPTEMBER 15 PUBLIC MEETING ON THE NRC

STAFF'S DRAFT SUPPLEMENT TO THE DEPARTMENT OF ENERGY'S EIS FOR THE PROPOSED REPOSITORY AT YUCCA

MOUNTAIN, NEVADA

On Tuesday, September 15, 2015, members of the U.S. Nuclear Regulatory Commission (NRC) staff held a Category 3 public meeting at the Embassy Suites Convention Center in Las Vegas, Nevada. The purpose of the meeting was to provide an overview of the NRC staff's draft supplement to the U.S. Department of Energy's (DOE) environmental impact statement for the proposed high-level waste repository at Yucca Mountain, Nevada, and to accept public comments on the document. Participants had an opportunity to ask clarifying questions about the NRC's environmental review process.

The public meeting began at 7:00 p.m. Pacific Time, following a one-hour open house for stakeholders to engage with the NRC staff. The meeting began with an introduction of NRC staff and a review of meeting ground rules, followed by a presentation on the draft supplement. Meeting attendees were then given the opportunity to ask clarifying questions and present their comments. Twenty-eight individuals provided comments. The meeting concluded at approximately 9:35 p.m.

Approximately 70 people attended the meeting. Meeting attendees included members of the public, members of federal, state, and local governments, members of tribal governments, and

members of industry and public advocacy groups. A list of meeting attendees is attached to this summary.

Clarifying questions from the attendees included: whether the NRC has more than one definition for a "small" impact that it uses in its National Environmental Policy Act documents; and how or why DOE is able to "defer" to the NRC to develop the supplement.

Topics raised during the comment period included concerns about the NRC's process or about technical aspects of the supplement, concerns about broader polices or processes relevant to Yucca Mountain, and other issues directly or indirectly related to Yucca Mountain or the proposed repository. Comments about the supplement or about the NRC's process for developing the supplement addressed the following issues: concern about the NRC's role in preparing the supplement and a lack of federal funding for affected local governments to pay for a technical review of the draft supplement; concerns about the assumptions and scope of the supplement; a request that the NRC staff acknowledge in the final supplement that recent developments may result in significant program changes (e.g., the Administration's announcement of plans to dispose of defense waste separately), thus creating a need to update DOE's EISs; the supplement's reliance on DOE's model of repository performance; the stability of the geology at the proposed repository site; skepticism about DOE's plan to install titanium drip shields in the proposed repository; the potential for the proposed repository to leak contaminants into the groundwater moving through Nevada into California; the possible effects of groundwater contamination or an accident on the Las Vegas economy; concerns about the interaction among contaminants in the groundwater; and concerns about impacts on the spiritual and healing qualities of the water used by tribes, as well as other potential impacts on tribal lands, populations, and wildlife. Some commenters expressed their view that the repository would pose no danger and would not contaminate groundwater. Commenters also expressed concern that the NRC staff did not hold public meetings in California. Other commenters requested that the public comment period be extended beyond the November 20 deadline.

General policy or process comments addressed the following topics or concerns: expressions of general opposition to the proposed repository and concern that the project might continue despite such opposition; concerns that decisions about the Yucca Mountain site and the proposed repository have been politically motivated; recognition that the project cannot move forward in light of events that have occurred or decisions made since DOE submitted its license application in 2008; concerns about how the U.S. government has affected the people and lands of the Western Shoshone Nation; support for choosing a repository site based on informed consent; support for recycling, treating, or finding other uses for spent nuclear fuel; and support for nuclear power in light of global climate change.

Other commenters compared the history of nuclear activities on the Nevada Test Site to the potential for impacts from the proposed repository. Some commenters emphasized that DOE does not have the necessary land withdrawal and water rights to construct and operate a repository at Yucca Mountain. Additional comments concerned the risks of transporting spent nuclear fuel; possible train or truck routes for transporting high-level waste through Nevada; the design of spent nuclear fuel storage canisters and the potential for stress corrosion cracking; and concern that the NRC has cancelled a study to determine the long-term cancer risk to people living near nuclear power plants and the implication for potential NRC regulation of a high-level waste repository.
