Enclosure 2 Prioritized Fiscal Year 2017 Rulemaking Activities

The staff used Commission developed criteria to perform the common prioritization and rebaselining of all planned Fiscal Year (FY) 2017 activities. As directed in Staff Requirement Memoranda (SRM)-15-0015, staff aligned the planned work with the Nuclear Regulatory Commission's (NRC's) mission, Principles of Good Regulation, and Values.

This enclosure summarizes the results of common prioritization and re-baselining for rulemaking activities. These activities were taken from the budget "Product" for rulemaking and for the Fukushima Near Term Task Force work. Activities to incorporate by reference certified designs into 10 CFR Part 52 were treated as Licensing, and are not included in this list.

Activities, including rulemaking, with minimal levels of resources (generally less than one Full Time Equivalent staff person) were not included in common prioritization or re-baselining unless they were tied to a specific efficiency improvement. Inclusion of work activities with such nominal resources would not have been efficient.

The common prioritization list below was developed in November 2015. Information available at that time, which was more current than during initial budget planning, led to the modification of priorities and plans. Additionally, information developed since November led to two additional rules (not listed below) being included in the final proposed FY 2017 budget.

For the reasons cited above, as well as the use of somewhat different evaluation criteria, this list does not align directly with other lists of rulemaking and rulemaking support activities, including the Rulemaking Activity Plan.
