International Workshop on the Use of Robotic Technologies at Nuclear Facilities

On February 2 - 4, 2016, RES and the Office of Nuclear Material Safety and Safeguards sponsored an International Workshop on the Use of Robotic Technologies at Nuclear Facilities with co-sponsors: Department of Energy (DOE); Department of Homeland Security; the Canadian Nuclear Safety Commission; United Kingdom's Atomic Energy Authority; the Organization for Economic Cooperation and Development / Nuclear Energy Agency; and the workshop host, the National Institute of Standards and Technology (NIST).

The workshop objectives were to assess past, present, and anticipated uses of remote systems and robotic technologies in safety applications and decommissioning activities at nuclear facilities. The workshop presentations and demonstrations focused on: (1) the current state-of-the-practice in using robots; (2) practices, lessons learned, and challenges of robotic deployment at the Fukushima Daiichi Nuclear Power Station; (3) industry and government experiences in applying robotic technologies to existing challenges; (4) ground-breaking, innovative technologies and new opportunities; and (5) robot testing, operator training and certification, and regulatory standards development.

Over 150 engineers and scientists from U.S. nuclear utilities, DOE national laboratories, international companies, government agencies both domestic and international, and academia attended the workshop to share knowledge and experiences in robotic development and deployments. NRC, NIST, and DOE will post the video of the workshop, presentations, and significant lessons and websites.
