Staff Issuance of the Draft Environmental Impact Statement for Northwest Medical Isotopes

On October 31, 2016, the staff issued for public comment the draft environmental impact statement (EIS) for the Northwest Medical Isotopes, LLC (NWMI), medical radioisotope production facility construction permit application. The staff's preliminary recommendation, unless safety issues mandate otherwise, is the issuance of a construction permit to NWMI. As part of its environmental review, the staff will hold a public meeting on December 6, 2016, in Columbia, Missouri, near the proposed facility location to discuss the preliminary findings in the draft EIS and to solicit public comments on the document. The public comment period ends on December 29, 2016.
