INSTRUCTIONS TO STUDENTS

ACCEPTANCE: This is to advise you that those individuals in Enclosure 1 have been accepted for participation in the training course Safety Aspects of Industrial Radiography (H-305). This course is scheduled to be presented October 23-27, 2017, at Source Production and Equipment Company (SPEC), 113 Teal Street, St. Rose, Louisiana. SPEC is located in the James Business Park, a couple of miles west of the airport off of US Highway 61. The telephone number for the training site is (504) 464-9471. If you are unable to attend this course, please contact Marcia Casby at (301) 415-6525.

COURSE: The course starts at 8:00 a.m. on Monday, October 23, 2017 and ends at 12 noon on Friday, October 27, 2017. Students should bring dosimetry (dosimetry will be available for those who do not have issued dosimeters) and a scientific calculator. You will have the opportunity to make a radiograph of something of your choice during this class. If you want to bring something with you to radiograph, it must fit on film that is approximately 4 x 8 inches. Students may dress comfortably in business casual attire that will facilitate laboratory exercises.

LODGING AND TRAVEL: Please plan to arrive on Sunday, October 22, 2017, and depart on Friday, October 27, 2017. Students must make their own lodging and travel arrangements. If traveling by air, please contact El Sol Travel at (844) 244-6694 for airline reservations and indicate that the travel is "Invitational" for the NRC. Please select a fully refundable Government fare if one is available, and make sure that El Sol Travel correctly direct bills your fare to credit card ending 2835. Flights may be converted to less costly, non-refundable tickets, so please select carefully. If the need arises and you must make a change, please contact Marcia Casby at (301) 415-6525.

Please complete the Travel Application Form which will be provided to you and submit to Marcia Casby, Astrainingandtravel.Resource@nrc.gov, at your earliest opportunity, but no later than August 25th. If you plan to drive, the Federal mileage reimbursement is 53.5 cents per mile. Rental cars are not authorized for travel. The FY2018 per diem rates have not yet been established, but you will be notified as soon as they are posted. Please request the Federal Government rate at your hotel. The following hotel is located within a short distance from the training site. Please request the complimentary shuttle service which is available between the airport and the hotel, as well as the training center. Please contact the front desk for details upon arrival. Those students who elect to stay at an alternate hotel will be responsible for their own transportation.
