REMARKS:

IMC 1245, "Qualification Program for Reactor Inspectors," has been revised to make editorial updates to the document by removing references to old programs such as iLearn and updating the names of offices and branches in NRR and NSIR. Additional guidance regarding the type of questions that should be asked in an inspector qualification board was added. This revision also deleted Attachment 3 of this IMC since the information contained in the attachment was duplicative of information that is readily available on the OCHCO intranet websites.

IMC 1245 Attachment 1, "General Overview of the Inspector Training and Qualification Program," has been revised to update branch names and training descriptions.

IMC 1245 Attachment 2, "Inspector Competencies," has been revised to correct/clarify some working in the document.

IMC 1245 Attachment 3, "General Orientation Topics," has been deleted. Information contained on IMC 1245 Attachment 3 is duplicative of information that is readily available on the OCHCO intranet websites.

IMC 1245 Appendix C5, "Research and Test Reactor Inspector Technical Proficiency Training and Qualification Journal," has been revised to update references to courses and corrected format items.

IMC 1245 Appendix C7, "Fire Protection Inspector Technical Proficiency Training and Qualification Journal," has been revised to remove references to out of date applications, procedures, office titles and training courses. It also removed ISA-4, which referred to B.5.b related inspection activities that are no longer performed by Fire Protection Inspectors. Feedback form 1245C7-2411 which recommended providing an alternative external training course for one that is no longer listed is closed with alternatives.

This revision also added additional providers for the nuclear power plant fire protection course as recommended by feedback form 1245C7-2411.

IMC 1245 Appendix C9, "Senior Reactor Analyst Training and Qualification Program," has been revised to update references to SharePoint sites and the names of several office titles that were renamed as part of the NRR reorganization. Several format items were corrected.

IMC 1245 Appendix D2, "Inservice Inspection Advanced-Level Training," has been revised to updated references and removed course E-118 as a training option. In place of the E-118 course, E-901 was offered as an option. This revision also recognized how the adoption of 10 CFR 50.69 may impact licensee ISI and IST programs. This revision also removed references to out of date websites and procedures. Feedback form 1245D2-2393, which recommended addition of an AMSE stress analysis course to the training program was included in this update as a suggested training course.

IMC 1245 Appendix D3, "Fire Protection Advanced-Level Training," has been revised to remove the NFPA Sprinkler Hydraulics Seminar training requirement which was no longer offered and provided new training choices that were recommended by the NRR technical program office. Also, this revision updated links that were not functional.
