Upon receipt of your request, our office tasked the Office of Nuclear Reactor Regulation (NRR) to search for any responsive records. NRR staff located only one record, which has now been reviewed and determined to be available to the public. You may find this record in the NRC's official recordkeeping repository, Agencywide Documents and Access Management System (ADAMS) as ML023360030. If there was additional documentation accompanying that letter, it has not been retained. We note that, in an August 26, 2008 letter (which is publicly available in ADAMS as ML081500506), it is stated that WPI withdrew your license renewal application, by letter dated November 19, 2007.
